

Sir,

Sub.:- Proposal for providing one Excavator and one Bulldozer, 2 Nos. Mini Compactors and 4 Nos. Tractors with Trailers ((Hydraulic System) for the regular maintenance of existing dumping ground and collection and transportation of wastes in Berhampore Municipal area.

I am to bring to your kind attention that Berhampore Municipality is comprised of 28 Wards having population of 1.93 Lakh according to Census'2011. Geographical area of this Municipality is 31.42 Sq Km. Wastes generated per day is 90 M.T. approx. Area of the existing dumping ground is 2.30 Acre and it is overloaded by heaps of wastes in a scattered way. There is no space for dumping the wastes being generated in each day. Even roadside flank beside the dumping ground is filled up by wastes. As a result traffic system of the adjoining road of the dumping ground is being obstructed. There is no passage for entering the loaded vehicle of wastes in the dumping ground. So the dumping ground is required to be maintained regularly in a routine way by way of storing the wastes in one side of the dumping ground and to do the job, all the heaps of wastes spreading all through the dumping ground is required to be pushed and removed and to be dressed to the surface level of the dumping ground regularly in a routine way. The above job will also enable this Municipality to maintain cleanliness of the adjoining area and also to minimise the pollution of the environment of the surrounding areas.

Two nos, large size Compactors have already been provided to this Municipality by the SUDA under SBM and the Compactors are being operated through the derived route chart within the Municipal area in a regular way for which cleanliness of the town is maintained in a more improved way and we are exercising our best efforts to achieve the objectives of the SBM.

Further more it is noted that many high rising buildings have been constructed within this Municipal town. Population of the town is gradually being increased. Amount of wastes generation is rising up substantially. Tractors and trailers in possession of this Municipality is insufficient than that of actual requirement.

More 2 Nos. Mini Compactors for getting access in to the narrow road and 4 Nos. Tractors with Trailers (Hydraulic System) are in emergent need of this Municipality for collection and transportation of surplus wastes being generated in each day due to growth of population

In order to regular maintenance and optimum utilization of the existing dumping ground and collection & transportation of total generated wastes, this Municipality is in dire need of (1) one Excavator and (2)one Bulldozer (3) two Nos. mini Compactors (4) 4 Nos.
