In reference to above this is to mention that the Joint Secretary to the Govt. of West Bengal, has forwarded a copy of letter No. PW/TEN/XI/1M-1/2019/51 that submitted by The Commissioner, Chandannagar MC on the subject matter sited above (placed at CP-13 & 14).

It is stated that regarding Boi-remidial/Phyto-remedial measures of outfall to River Hoogly within the jurisdiction of Chandannagar MC, the CMC had inspected and identified 41 nos. small & big outfalls which discharge waste water directly into River Hoogly (placed at CP- 6 to 12 as annexure-I).

They had also engaged an agency to prepare a concept note & preliminary cost estimate to the tune of Rs.336.77 lakh(initially for 1 year) for In-situ Bioremediation Methology for reducing BOD/COD & other harmful parameters from 41 nos outfall & ensuring safe discharge of water into river (placed at CP-1 to 5 as Annexure-II).

Now the Commissioner, CMC stated that they like to proceed with the said project on urgent basis and requested DU&MA Deptt. to allot fund for the said project.

As the matter relates to recent Order issued by The Hon'ble NGT to prevent pollution of River Ganga and as CMC is one of listed Ganga Town we may request MA Deptt. for Budgetary provision of fund for the proposed project. However Detail Project Report with cost estimate for the project, duly vetted by competent authority, is necessary before allocation of actual fund.

If approved the matter may be placed to the Deptt. for kind consent.
