The Bid Evaluation cum Tender Committee duly formed as per approval of the Principal Secretary, UD&MA Department, Govt. of West Bengal to evaluate the financial bid as received for procurement of 60222 numbers of HDPE plastic Green and Blue colour Community Bins of 100 litre capacity each for 124 ULBs in West Bengal through online e-Tender portal, met in its twenty second meeting on October 01, 2020.

Director – SUDA started the meeting with a brief note on the proceedings of the 21st meeting of the Bid Evaluation cum Tender Committee of SUDA and placed the minutes of the 21st meeting before the committee for its confirmation. The Committee perused and confirmed the same.

The tender for the subject work was floated online through e-Tender portal on 25.08.2020 with bid due date being 16.09.2020. The technical bids were opened on 18.09.2020. After the due evaluation of technical bids, the Bid Evaluation cum Tender Committee recommended opening of financial bid of the technically qualified bidder on 28.09.2020. The financial bid of the technically qualified bidder on e-Tender portal for procurement of 60222 numbers of HDPE plastic Green and Blue colour Community Bins of 100 litre capacity each for 124 ULBs in West Bengal was opened on 30.09.2020.

The summary of the financial bid is as follows:

The Committee observed the above rates as quoted by the technically qualified bidder and inferred that the rate quoted by M/s. Nilkamal Limited (Rs. 5,85,35,868.31) for procurement of 60222 numbers of HDPE plastic Green and Blue colour Community Bins of 100 litre capacity each for 124 ULBs in West Bengal was the lowest rate (L1).

The Committee also observed that the rate of each HDPE plastic Community Bins of 100 litre capacity as proposed by L1 bidder through e-Tender portal under this tender is lower than the tender rate (Rs. 1560.00 per HDPE plastic Community Bins of 100 litre capacity) as floated on e-Tender portal. The Committee recommended for acceptance of the rates (which is Rs. 972.00 per HDPE plastic Community Bins of 100 litre capacity inclusive of all taxes & duties, GST, transportation, freight & sample testing) offered by M/s. Nilkamal Limited which is L1 bidder for the procurement of 60222 numbers of HDPE plastic Green and Blue colour Community Bins of 100 litre capacity each for 124 ULBs in West Bengal and directed the Superintending Engineer, SUDA to undertake all necessary steps to complete the procurement process and initiate the process of supply order within the bid validity period subject to approval from the Single Departmental Tender Committee of UD&MA Department.

The meeting ended with vote of thanks to and from the chair.

The Bid Evaluation cum Tender Committee duly formed as per approval of the Principal Secretary, UD&MA Department, Govt. of West Bengal to evaluate technical bidding process for procurement of 60222 numbers of HDPE plastic Green and Blue colour Community Bins of 100 litre capacity each for 124 ULBs in West Bengal through online e-Tender portal, met in its twenty first meeting on September 28, 2020.

Director - SUDA started the meeting with a brief note on the proceedings of the 20th meeting of the Bid Evaluation cum Tender Committee of SUDA and placed the minutes of the 20th meeting before the committee for its confirmation. The Committee perused and confirmed the same.

At the outset, Superintending Engineer, SUDA explained the bid's terms & conditions along with the specifications of the HDPE plastic Green and Blue colour Community Bins of 100 litre capacity each before the Committee Members that has been opted on e-tender portal for the present procurement.

The Committee accepted the bid's terms & conditions along with the specifications as was iterated in this procurement process.

Then, a synopsis of the bid documents submitted by the bidders was presented before the Committee by Superintending Engineer, SUDA. After a threadbare discussion following observations were made:



Evaluation of Technical Bids for HDPE plastic Green and Blue colour Community Bins of 100 litre capacity each:

- 1. Two bids by two different agencies were submitted for HDPE plastic Green and Blue colour Community Bins of 100 litre capacity each. The names of the bidders are as follows:
 - a. M/s Prova Irrigation Equipments Co
 - b. M/s Nilkamal Limited
- 2. On thorough scrutiny of the bids, the Committee observed the following:

1.	M/s. Prova Equipments Co	Irrigation	i. ii.	Does not have experience with Central & State Govt/PSU/ULB for supply similar nature of completed work for the minimum value of 30% of the estimated amount put to tender during 5(five) years. Does not have Injection Moulding Machine for manufacturing of Community Bins of 100 litre capacity.

- 3. In light of the above grounds it was decided by the Committee that M/s Nilkamal Limited found eligible for participating in the financial bid for supply and delivery at site of 60222 numbers of HDPE Plastic Green & Blue coloured Community Bins of 100 litre capacity each for 124 ULBs in West Bengal.
- 4. On scrutiny of technical specifications and general terms & condition, it was decided by the Committee that M/s Prova Irrigation Equipments Co failed to qualify for technical evaluations and participate in the financial bid for supply and delivery at site of 60222 numbers of HDPE Plastic Green & Blue coloured Community Bins of 100 litre capacity each for 124 ULBs in West Bengal.

As the referred call is 2nd call and one bidder is found technically qualified, the Committee recommended for opening of the financial bid on the e-tender portal of the technically qualified bidder, i.e M/s Nilkamal Limited and places the same before it at its next meeting for further decision.

The meeting ended with vote of thanks to and from the chair.


