#### General Consideration:

- 1. The selected candidates shall be engaged to the post of HHW by the ULB on monthly honorarium of Rs. 4500/- per month per HHW.
- 2. The engagement shall be made purely of contract initially for a period of 1 (one) year from the date of joining and shall be extended further on the basis of her satisfactory performance.
- 3. Since it is an honorary engagement, not a regular or contractual engagement, to fill up the vacancy 100 point roster is not applicable.

## Guideline for selection of HHW

- Eligibility criteria for candidate:
- 1. The candidate must be resident of the ULB concerned.
- 2. Must be Female in the age group of 30-40 years as 1st. day of January, 2024. In case of SC/ST/OBC-A/OBC-B) candidates, the lower age limit may be relaxed to 22 years.
- 3. Should be married/divorced/widow.

- 4. Minimum Madhyamik or equivalent examination pass, and only marks obtained in ME or equivalent exam. will be considered in case of candidates with higher qualification.
- The selection would be based on:
  - 1. Marks obtained in ME or equivalent exam ((90% weightage)
  - 2. Score in the Interview (10% weightage)
  - 3. Having motivation/experience of rendering social services.

All applications in prescribed format (attached herewith) are to be submitted physically at the municipal office (BMC Poura Bhawan Ground Floor, FD 415A, Sector-III, Salt Lake City, Kolkata 700 106) in the designated drop box, within – 12th February, 2024.
