- > The remaining amount of 1st instalment (i.e., 80%) will be released on receipt confirmation of deposit of ULB Contribution on account and/or arrangement thereof.
- The rest of the amount after 1st instalment will be released on receipt of Final RA Bill and validation of all confirmed beneficiaries in PMAY-MIS Portal.
