- A subsidiary Cash Book should be maintained for keeping accounts (deposits and withdrawals) of funds.
- The remaining amount will be released on receipt confirmation of correction of Aadhar of the beneficiaries.
- The rest of the amount after 1st instalment will be released on receipt of Final RA Bill and validation of all confirmed beneficiaries in PMAY-MIS Portal.


