- (b) **Honorarium for 04 (four) Special Teams i.e. [16 (sixteen) House to House Team Members @ Rs. 175/- per person per day for 120 days; 04 (four) Special Team Supervisors, 16 (sixteen) Conservancy Team Members and 08 (eight) Spray Workers @ Rs. 202/- per person per day for 120 days (i.e. 1<sup>st</sup> September to 31<sup>st</sup> December, 2025)] to intensify Vector Control activities through sustained House-to-House surveillance and awareness campaigns for removal of potential mosquito breeding sites at 08 (eight) vulnerable wards under Bidhannagar MC for Prevention and Control of Vector Borne Diseases for the year 2025.**
