ALLOTMENT ORDER

Pursuant to the allotment order issued by the UD & MA Department vide no 159(Sanction)/UDMA-13014(12)/125/2022-BDG-MA SEC-Dept. Of UDMA dated 27.05.2022 of West Bengal Urban Employment Scheme an sum amount of **Rs. 4,17,67,000/-** (Rupees Four Crore Seventeen Lakh Sixty Seven thousand only) devolved in favour of 08 ULBs (From Serial no 01 to 08) as the **1st Instalment** (20% of yearly requirement during 2022-23). ULB wise allotment order of UD & MA Department is annexed.

1. The amount of allotment has to be utilised for the manpower already engaged/to be engaged (Categories of man power as detailed in table below) for scientific management of municipal Solid Waste of ULBs in a segregated manner in compliance with SWM Rules 2016.
2. The amount of allocation of fund from next allotment to be devolved depending upon the number of wards where 100% source segregation has been ensured, segregated collection & transportation in compliance with SWM Rule 2016.
3. The amount to be disbursed to every individual category as mentioned below as has been engaged.
4. The allotment is to be utilized for payment of wages to different category of workers engaged in conservancy activities only.
5. Scientific management of Municipal Solid Waste to be carried out in conformity with the Solid Waste Management Rules 2016 and as per the directions passed by the Hon'ble National Green Tribunal from time to time.
6. Utilization Certificate is to be submitted at the www.sbm.wbsuda.com portal. Subsequent release of instalments will only be made on receipt of previous Utilization Certificate.
7. Fund is not to be utilized for any other purpose other than the purpose for which it has been sanctioned.
8. Attendance of workmen should be maintained on regular basis.
