- The amount released herein should be kept in the dedicated Bank Account for PMAY maintained by the ULB.
- A subsidiary Cash Book should be maintained for keeping accounts (deposits and withdrawals) of funds.
- Money receipt in Form 42 may be sent immediately after receipt of the online transfer.
- ➤ The rest of the pending amount of ₹ 3,61,400.00, withheld for 1 (one) beneficiary will be released on validation of Aadhar of the beneficiary attached in the Project Year.
