- 6. The amount released herein should be kept in the dedicated Bank Account for HFA (U) maintained by the ULB.
- 7. A subsidiary Cash Book should be maintained for keeping accounts Deposits and Withdrawal of funds.
- 8. Money receipt in Form 42 may be sent immediately after receipt of the online transfer.
