INDIRA GANDHI NATIONAL WIDOW PENSION SCHEME (IGNWPS)

- ✓ Kindly note that aforesaid fund comprises Pension for the month of February, 2020 & March, 2020 in revised rate (Rs.600/- p.m. for IGNWPS beneficiaries within the age group of 40-79 years).
- ✓ This Pension should be disbursed forthwith to the concerned beneficiaries immediately after receiving of fund through electronic transfer from SUDA and strictly for the period as specified in the enclosed Annexure only.
- ✓ Unspent fund under IGNWPS may be utilized for the purpose of disbursement of pension for the period as specified in the enclosed Annexure only.
- ✓ The Money Receipt in Form 42 may kindly be sent immediately after receiving the fund through electronic transfer.
- ✓ The Monthly Pension amount should be disbursed immediately only through the <u>Bank</u> or Post Office Account of the beneficiary concerned.
- Monthly Progress Report regarding disbursement of pension under IGNWPS are required to be sent within 5th of every month to SUDA in the prescribed "Monthly Progress Report (MPR)" Proforma.

Utilisation Certificate of cumulative funds since received from SUDA upto 31^{st} March, 2020 may please be sent to this office in GFR-12C within 30^{th} April, 2020 and uploaded at sudawb.org \rightarrow e-services positively.
