An advance copy of the progress report is to be submitted to SUDA within the 3<sup>rd</sup> of every month.
- (4) Utilisation Certificate of the funds received from SUDA may please be sent to the Executive Engineer concerned for authentication and onward transmission to the Superintending Engineer, MED and to this office and uploaded at sudawb.org->e-services.
- (5) The amount released herein should be kept in the dedicated Bank Account for PMAY-HFA (U) maintained by the ULB.
- (6) A subsidiary Cash Book should be maintained for keeping accounts (deposits and withdrawals) of funds.
- (7) Money Receipt in Form 42 may be sent immediately after receipt of the online transfer.

(8) The 2<sup>nd</sup> and final instalment to be released after receipt of the final bill details.
