Sub : Release of funds for Capacity Building activities under Swachh Bharat Mission

Sir/Madam,

You are perhaps aware that Capacity Building activities under Swachh Bharat Mission is an important component under the program to ensure sustainability of the benefits accrued to the community from the physical infrastructure created under the Mission. Funds have been and are being released for field level components of the program like Individual Household Latrines, Solid Waste Management (provision of compactors) etc.

Funds are now being released to all Urban Local Bodies as per statement enclosed for Capacity Building activities under SBM. The admissible activities under the component Capacity Building include the following:

1. ULB level workshops for sensitizing the community towards Swachh Bharat Mission.
2. Ward level briefing meetings for sensitizing the community.
3. School Children Awareness Program in all schools within the jurisdiction of the ULB.
4. Focus group sensitization events for community led Total Sanitation Campaign (TSC) to cover youth clubs and women's group including self-help group.
5. Focus group sensitization program on SBM surveillance with senior citizens.
6. Technology sensitization programs for Municipal Engineers and Sanitary Inspectors for adoption of newer models of toilets with low water requirement.
7. Sensitization programs for Municipal Engineers and Sanitary Inspectors on Septage Management and conversion of insanitary latrines to pour flush sanitary ones.
8. Training program of local masons for construction of two-pit individual latrines.

You are requested to kindly take up appropriate activities in your town with the funds released under Capacity Building and send periodic reports to this Office and also to Government of India (by uploading in their portal) periodically.
