Sub: Release of fund for project sanctioned under HFA(U) in the Project Year 2018-19 as mentioned in Annexure-A attached for construction of Dwelling Units.

Madam / Sir,

Fund is being released to your Municipality as mentioned hereunder under HFA(U).

The release is also subject to the following conditions:

- The funds are since being allotted in totals and not Project Year wise, the ULBs are to maintain Project Year wise receipt & utilisation of funds. Allotment order for fresh releases will be generated and uploaded in the Official website of SUDA.
- Funds are to be transferred to the beneficiaries only through NEFT. No cash / self-cheques/ bearer cheques are to be drawn for payment to the beneficiaries.
- 3. A subsidiary Cash Book should be maintained for keeping accounts Deposits and Withdrawal of funds.
- 4. Money receipt in Form 42 may be sent immediately after receipt of the online transfer.
- 5. After a month of allotment of funds, if unutilized fund limits stand at 50% of the allotted amounts, the same shall be completely withdrawn & reallotted to other ULBs with good progress of the projects.
- 6. The funds are to be taken as a pool and can be used interchangeably within the projects as per requirement.
- 7. MED authenticated Utilisation Certificates (U.C.s) are to be submitted each month, within 10th of next month. If U.C. is pending for more than Rs. 50 lakh, further allotment of funds shall be stopped.
