5. **Utilisation Certificate** of the funds received from SUDA may please be sent to the Executive Engineer concerned for authentication and onward transmission to the Superintending Engineer, M.E. Dte and to this office and also uploaded at sudawb.org->e-services positively.
6. The amount released herein should be kept in the dedicated Bank Account for HFA (U) maintained by the ULB.
7. A subsidiary Cash Book should be maintained for keeping accounts Deposits and Withdrawal of funds.
8. Money receipt in Form 42 may be sent immediately after receipt of the online transfer.


