5. A & OE fund should be utilised for meeting registration related expenses of ALF/ travelling expenses incurred for formation and registration of ALF etc.
6. A monthly statement of Utilisation of **CB & T, SM & ID, I.E.C AND A & OE** so released should be submitted.
7. The execution of the schemes should be strictly as per the NULM guideline.
