(IGNDPS)**

Fund is hereby released electronically in favour of Municipalities / N.A.A. / Corporations for the month of February, 2014 (01 Month) in revised rate alongwith additional benefit for the period from October, 2012 to January, 2014 under IGNDPS as communicated vide P & R.D. G.O. No.1308/PN/P/II/3F-9/2006 (Pt.-II) dated 28.03.2013 and as per details shown in the following pages for implementation of Indira Gandhi National Disability Pension Scheme (IGNDPS).

Kindly note that aforesaid fund comprises –

- (c) Pension for the month of February, 2014 in revised rate (Rs.600/- p.m. for IGNDPS beneficiaries within the age group of 18-79 years).
- (d) Additional benefit @ Rs.200 p.m. (i.e. Rs.600/- minus Rs.400/-) for the disabled beneficiaries belonging to age group of 18-79 years under IGNDPS for the period from October, 2012 to January, 2014.
- ✓ This Pension should be disbursed forthwith to the concerned beneficiaries immediately after receiving of fund through electronic transfer from SUDA and strictly for the period as specified in the enclosed Annexure only.
- ✓ Unspent fund under IGNDPS may be utilized for the purpose of disbursement of pension for the period as specified in the enclosed Annexure only.
- ✓ The Money Receipt in Form 42 may kindly be sent immediately after receiving the fund through electronic transfer.
- ✓ The Monthly Pension amount @ Rs.600/- per month per beneficiary should be disbursed immediately only through the Bank or Post Office Account of the beneficiary concerned. In case of necessity, Joint Account may be opened with the person who looks after the beneficiary (preferably with someone who has blood relationship with the beneficiary).
- ✓ Monthly Progress Report regarding disbursement of pension under IGNDPS are required to be sent within 5th of every month to SUDA in the prescribed “Monthly Progress Report (MPR)” Proforma.
- ✓ Utilisation Certificate of cumulative funds since received from SUDA as on 28th February, 2014 may please be sent to this office in GFR-19A within 15th March, 2014 positively.
