MEMORANDUM**I.E.C, A & OE AND REVOLVING FUND UNDER NULM**

Funds are hereby released in favour of Municipalities towards I.E.C, A & OE Revolving Fund under NULM as indicated in pages from 2 to 5.

1. The fund, so released, should be kept in a Bank Account of any **Nationalised Bank** in your area under SJSRY with a separate ledger for NULM.
2. The Municipality will release the required amount of Revolving Fund in favour of the Thrift and Credit group having **Bank accounts** in their own name. The sanction of Revolving Fund should be made by the Municipality strictly adhering to the Guidelines of Thrift and Credit Programmes under NULM, already circulated. The Utilization of Revolving Fund by the Thrift and Credit groups should be closely monitored by the Town Project Officer (Asst. Project Officer)/ Community Organiser concerned of your Municipality.
3. A monthly statement of Utilisation of I.E.C,A & OE and Revolving Fund so released should be submitted .
4. Fund for I.E.C. should be utilised for organising mass awareness camps, banner, flex, leaflets and SHG related Bank linkage activities etc.
5. A & OE fund should be utilised for formation of ALF and SHG including awareness generation.
7. The execution of the schemes should be strictly as per the NULM guideline.
8. The money receipt in **Form 42** may be sent immediately after receiving the fund.
