MEMORANDUM**Building Community Institutions :Payment to Resource Organisation for formation of SHGs and their Federations under SM & ID component of NULM**

Funds are hereby released in favour of Municipalities towards 10% of total amount payable to ROs for the purpose of Community Mobilisation under **Building Community Institutions : SHGs and their Federations under SM & ID - NULM** as indicated in page 2 to 4 subject to the following conditions.

1. The fund, so released, should be kept in a dedicated Bank Account of NULM.
2. All ROs will be entrusted initially to form at least 50 SHGs within its jurisdiction.
3. ULB will provide of fund of Rs.20, 000/- as advance to each RO for mobilization support.
4. Out of 7 stages of payment, ULB can club more than one payment together for convenience.
5. RO will place claim to ULB with proper documents after completion of a particular stage for a group of SHG and not for each and every SHG repeatedly.
6. ULB will claim further fund from WBSULM after utilizing earlier fund sub-allotted with relevant documents. WBSULM will sub-allot fund thereafter based on claim & scale of payment agreed upon.
7. UC is to be submitted to WBSULM for all releases made under SM & I D.
