- The unit cost for construction of IHHL may be taken as Rs 13,000/-
- The Municipal Affairs Department has been requested for making available the balance fund from state exchequer as Additional State Share amounting to Rs.5,70,30,740/- (Rupees Five Crore Seventy Lakh Thirty Thousand Seven Hundred Forty) only.
- The latrine unit shall be complete with superstructure and two-pit disposal system.


