## **MEMORANDUM**

## Revolving Fund (RF) Support to TCGs/SHGs under SM & ID component under NULM

Funds are hereby released in favour of Municipalities towards Revolving Fund as indicated in page 2 under NULM.

- 1. The fund, so released, should be kept in a Bank Account of any **Nationalised Bank** in your area under SJSRY with a seperate ledger for NULM.
- 2. The Municipality will release the required amount of Revolving Fund in favour of the Thrift and Credit group having **Bank accounts** in their own name. The sanction of Revolving Fund should be made by the Municipality strictly adhering to the Guidelines of Thrift and Credit Programmes under NULM, already circulated. The Utilization of Revolving Fund by the Thrift and Credit groups should be closely monitored by the Town Project Officer (Asst. Project Officer)/Community Organisor concerned of your Municipality.
- 3. Immediately after disbursement, a list of RF-receipent TCGs/SHGs is to be submitted to WBSULM alongwith their bank account details.
- 4. UC is to be submitted to WBSULM for all releases made under RF.
