MEMORANDUM

Revolving Fund (RF) Support to TCGs/SHGs under SM & ID component under NULM

The Utilization of Revolving Fund by the Thrift and Credit groups should be closely monitored by the Town Project Officer (Asst. Project Officer)/Community Organiser concerned of your Municipality.
3. Immediately after disbursement, a list of RF-receipt TCGs/SHGs is to be submitted to WBSULM alongwith their bank account details.
4. UC is to be submitted to WBSULM for all releases made under RF.
