**Sub : Release of funds for construction of Dwelling Units under BLC mode and allied
Infrastructure Development works under PMAY-HFA(U)**

Madam / Sir,

It may kindly be recalled that in the DPR for the year 2015-16 proposal for construction for Dwelling Units under Beneficiary Led Construction (BLC) mode as stated in Column-3 of the enclosed statement was received from your ULB. Your proposal after approval in the State Level Sectioning and Monitoring Committee has since been sanctioned by Government of India and the Government of India has released 31% of admissible 1st instalment of Central Share (40% of due Central Share) . In other words, 12.40% of the due Central Share has so far been received. In addition, SUDA has received 12.40% of the admissible State Share both for Housing and Infrastructure Development.

Now, funds as shown in Column-8 of the enclosed statement are being released electronically in favour of your ULB in the dedicated Bank account for PMAY as intimated by you. You are requested to deposit proportionate amounts of the fund shown in Columns 4 & 5 to all the beneficiaries mentioned in the DPR in their dedicated Bank Account with instruction to them to commence field level construction of the Dwelling Units following the Model Plan and conforming to the Operational Guidelines laid down in this office Order No.SUDA-17/2016/256 dt.11.02.2016. Depositing of funds for Dwelling Unit in a beneficiary's dedicated Bank Account may be kept in abeyance if the original beneficiary has expired or on scrutiny some disputes regarding the sole ownership of land has been detected by the ULB.

You are also requested to obtain an additional undertaking from the prospective beneficiary in addition to Annexure-1 of the Operational Guidelines prior to depositing funds for Dwelling Units in the beneficiaries dedicated Account to the effect that

- The beneficiary does not have in his / her ownership any pucca Dwelling Unit anywhere in the country
- The beneficiary has not / will not take advantage of any other vertical under PMAY like PPP, AHIP & CLSS for obtaining a Dwelling Unit for him / her.
