- ✓ **Unspent fund under IGNDPS may be utilized for the purpose of disbursement of pension for the period as specified in the enclosed Annexure only.**
- ✓ **The Money Receipt in Form 42 may kindly be sent immediately after receiving the fund through electronic transfer.**
- ✓ **The Monthly Pension amount @ Rs.600/- per month per beneficiary should be disbursed immediately only through the Bank or Post Office Account of the beneficiary concerned.**
In case of necessity, Joint Account may be opened with the person who looks after the beneficiary (preferably with someone who has blood relationship with the beneficiary).
- ✓ **Monthly Progress Report** regarding disbursement of pension under IGNDPS are required to be sent **within 5th of every month to SUDA** in the prescribed “Monthly Progress Report (MPR)” Proforma.
- ✓ **Utilisation Certificate of cumulative funds since received from SUDA upto 15th August, 2017 may please be sent to this office in GFR-19A within 31st August, 2017 positively.**
