- ✓ The Monthly Pension amount should be disbursed immediately only through the <u>Bank</u> or Post Office Account of the beneficiary concerned.
- ✓ Monthly Progress Report regarding disbursement of pension under IGNWPS are required to be sent within 5th of every month to SUDA in the prescribed "Monthly Progress Report (MPR)" Proforma.
- Utilisation Certificate of cumulative funds since received from SUDA upto 15th February, 2018 may please be sent to this office in GFR-19A within 15th March, 2019 positively.
