## **SUGGESTIONS FOR SHELTER HOMES WHO ARE RANKED BEHIND IN THE SECOND QUARTER OF AUDIT**

The following are the list of homes who have a point of less than 0.50 and have been assigned the remark of “average”, as per the analysis of the data received by respective shelter homes in the second quarter.

1. **TITAGARH**—SMC meetings and night surveys are not held frequently. Hence, it is advised to inquire into these categories. Most of the inmates do not possess ID cards such as Aadhar cards and Voter cards. Health satisfaction is reported to be less, and proper health checkups should be provided. Livelihood is low among the inmates, and new opportunities for livelihood should be created.
2. **BISHNUPUR**- Only 14% of the inmates receive Government schemes which should be enquired upon. The frequency of SMC Meetings and night surveys is low, and occupancy is very low. The livelihood situation is moderate.
3. **BHATPARA**—Most of the inmates do not possess ID cards such as Aadhar cards and Voter cards. None of the inmates are actively engaged in livelihood since most are old. SMC meetings are not held frequently. Only 35% of the inmates receive Government schemes which should be enquired upon.
4. **KATWA**—None of the inmates receive Government schemes, which should be enquired about. Seventy percent of the inmates do not possess an Aadhar card or a Voter card. None of the inmates are actively engaged in livelihood since most are old.
5. **ASANSOL DEPOPARA**- Only 9% of the inmates receive Government schemes which should be enquired upon. SMC Meetings are not held frequently; it has been held only thrice in the last year. Night survey are done moderately.
6. **MADHYAMGRAM**- Most of the inmates are not satisfied with the health service schemes. Occupancy is low in this home.
7. **ENGLISH BAZAR**- Only 15% of the inmates receive Government schemes which should be enquired upon. Occupancy is low at only 26%. Night survey is conducted moderately. Few of the inmates are actively engaged in livelihood since most are old.
8. **HARIDDEVPUR**- Only 2% of the inmates receive Government schemes which should be enquired upon. Since most of the inmates are old, the old age schemes should be made available to them.
