- Making Bore-Holes of 150 mm to 250 mm dia. by any standard method to any depth below ground level / bed level in all kinds of soil like clay, , silt, sand, stiff clay, mixed soils etc. except rocks (for the purpose of collecting Disturbed & Un disturbed soil samples, conducting Standard Penetration Test at suitable intervals etc.) including preparation and submission of bore-log as per IRC: 75 and 78 and Clause 2400 of Specifications for Road & Bridge Works (5th Revision), Published by IRC
