SUDA Invites Prospective bidders to participate in a pre-tender Conference to explore on a model for engagement of agencies to transport segregated municipal solid waste across 100 odd ULBs in the State.



1. SUDA is almost ready to float RFPs on behalf of 100 odd ULBs/ Corporations of the entire state to engage credible agency/ agencies to transport the Solid Waste materials of every nature, preferably from secondary transport point to processing plant on daily basis.
2. SUDA is keen to establish a unique transportation approach within the RFP, which is substantially different from any traditional transportation process. The Pre-tender meeting will review this transportation process in detail to ensure interested transportation agencies are prepared for successful participation. Transportation agencies are encouraged to send lead members of their team to attend the Pre-Tender Conference.
