The Bid Evaluation cum Tender Sub-Committee of SWAYAMSIDDHA MELA duly formed as per approval of the HMIC & Principal Secretary, UD&MA Department, Govt. of West Bengal to evaluate technical bidding process for the aforementioned works to organize SWAYAMSIDDHA MELA 2021 (From 14.02.2021 to 23.02.2021)

Addl. Director – SUDA started the meeting with a brief note on the NITs floated by this office for the aforesaid works.

At the outset, SMM-S & SI, NULM SUDA explained the bid's terms & conditions along with the specifications aforementioned works

The Committee accepted the bid's terms & conditions along with the specifications as were iterated in this process.

Then, a synopsis of the bid documents submitted by the bidders was presented before the Committee by SMM-S & SI, NULM SUDA. After a threadbare discussion following observations were made:

I) <u>Evaluation of Technical Bids for hiring of Fire Fighting Equipments for SWAYAMSIDDHA MELA 2021:</u>

- 1. Five bids by five different agencies were submitted for hiring fighting equipments for SWAYAMSIDDHA MELA 2021 as follows:

 - b. Global Prana
 - c. M/S- Subir Paul Chowdhury
 - d. Krisha Enterprises
 - e. Safe Pro Fire Services Pvt. Ltd
- 2. On thorough scrutiny of the bids, the Committee observed the following:

3.In light of the above grounds it was decided by the Committee that Barron Security Services Pvt. Ltd., Global Prana, M/S- Subir Paul Chowdhury, Krisha Enterprises found eligible for participating in the financial bid for the aforesaid works.

4. On scrutiny of technical specifications and general terms & condition, it was decided by the Committee that Safe Pro Fire Services Pvt. Ltd. failed to qualify for technical evaluations and participate in the financial bid for the aforesaid works.

As the referred call is 1 st call and four bidders are found technically qualified, the Committee recommended for opening of the financial bid of the technically qualified bidder, i.e, Barron Security Services Pvt. Ltd., Global Prana, M/S- Subir Paul Chowdhury, Krisha Enterprises and to declare the name of L1 bidder.
