2.1 Eligibility & Qualification of the Tenderer

- i) Eligible Tenderers must have Registered/Branch office within West Bengal.
- ii) Done and supervised similar kinds of job.
- iii) Copy of PAN Card along with IT Return & Balance sheet for the last financial year.
- iv) GST Registration Certificate.
- v) P.Tax and Trade License Certificate.

2.2 Rates and Quotes:

The rates quoted shall be inclusive of all taxes and duties as applicable as per the law. The quoted rates shall be firm and shall not be subject to any change whatsoever.

Rates quoted will be inclusive of cost of hiring charges of the following firefighting equipment, Operator, Taxes, Duties & Delivery Charges what so ever.

If the envelope(s) is/are not sealed and/or marked as instructed, application(s) shall be summarily rejected.

2.3 Time of submission

The tenders must reach the office of must drop in the drop box in the office of the State Urban Development Agency (SUDA) by 03-02-2021 upto 05:00 pm, SUDA may, at its own, sole discretion, extend the deadline for submission of tenders by issuing an amendment in accordance in which case all rights and obligations of State Urban Development Agency and the Tenderers, previously subject to the original deadline shall thereafter be subject to the new deadline as extended.

2.4 Opening of tenders:

The tenders shall be opened on 04-02-2021 at 11.30 AM in presence of such representatives of the Tenderers who wish to be present.

- 2.5 Tenderers shall have to deposit earnest money amounting to Rs. 2000.00 (Rupees Two thousand) only through Demand Draft in favour of SUDA payable at Kolkata. In case of failure, tenders shall be deemed invalid. The earnest money shall be automatically converted into Security Deposit for fulfillment of the Contract.
- 2.6 If the agency is selected, the Security @ 10% on contract value is to be deposited adjusting the EMD through Demand draft in favour of State Urban Development Agency payable at Kolkata. No work order will be issued until security Money is deposited.
- 2.7 Payment will be released only after due completion of SWAYAMSIDDHA MELA 2021 on receipt of duplicate bills & due recommendation from Concerned Sub-Committee.
- 2.8 The Contractor shall comply with all the bye-laws and regulations of local and other statutory authorities having jurisdiction over the works and shall be responsible for the payment of all fees and other charges and the giving and receiving of all necessary notices, and inform the said compliance with bye-laws, payments made, notices issued and received.
- 2.9 Failure to accomplish tendered work within stipulated time and to the satisfaction of component authority shall invite penal measures, financial and/or otherwise as may be prescribed by competent authority.
- 2.10 The bidder has to submit valid 15 digit GST No. under GST Act 2017 along with his bid.
- 2.11 The Financial offer of the prospective qualified tenderer(s) will be considered only if the technical bid of the tenderer(s) is found qualified by Component authority of State Urban Development Agency. The decision of the competent authority of SUDA will be final and absolute in this respect and no challenge against such decision will be entertained.
- 2.12 Tax invoice needs to be issued by the supplier for raising claim under the contract showing separately the Tax charge in accordance with the provision of GST act,2017 vide FD Memo No. 4374 dt. 13/7/17.
- 2.13 Mobilization advance will not be allowed.
- 2.14 Bid Documents are not transferable. All the tenderers must keep their offers valid for acceptance for a period of 90 days from the date of opening of tenders.

2.15 The accepting authority have the right to accept the lowest or any rate and also reserve the right to reject any part or in full or all tenders received and split up the work in different groups/phases without assigning any reason thereon.

2.16 Award of Contract:

The Bidder who's Bid has been accepted will be notified by the Tender Inviting & Accepting Authority through acceptance letter/Letter of Acceptance/ Work Order.
